FOREWORD

Due to the consistency shown by the scribe of this treatise in employing the singular, *exemplum*, whenever this word is used in chapter-headings and sub-headings, it was decided that such usage should be retained unaltered, even though this now results in the scribe's sole use of the plural, *exempla*, (*viz.* in the heading for *Capitulum V*) appearing rather incongruous.

The musical notation of this treatise seems to show an attempt to equate the *punctum* with the *brevis* and the *virga* with the *longa*: a process which would appear to be confirmed by the use of both the *plica brevis* (two types) and the *plica longa*. Possibly resulting from this, there appear in the manuscript *virgae* with note-stems of varying lengths and *puncta* with the suspicion of a beginning of a downward note-stem to the right (these *minutiae* are not reproduced in this edition), and also *climacus* forms in which the diamond-shaped notes may be preceded by either a *virga* or a *punctum*.
